4. Secretary Issues & EBVS news

EC gives a quick overview of the ECPHM Diplomates and compares the number of De Facto Diplomates vs Diplomates by Exam in 2008 vs 2021. The ECPHM has now 21% of Diplomates by examination, very important date for the college, it provides evidence of growing.



5. Treasurer's Report

H. Nathues

HN explains that Treasurer's report has been prepared by Monica Balasch the ECPHM Treasurer. Unfortunately MB was not able to join in presence, thus the report would be presented by the President.

HN compares incomes and expenses for the year 2020 and 2021.



The EC is constantly increasing the expenses for educational purposes. The report from financial auditors has been received on March 16. Alfonso López and Frédéric Vangroenweghe have reviewed all books and confirmed a correct management.

HN briefly shows the Estimated Budget 2022. The ECPHM is in a very good standing. HN asks whethere there are any questions from the floor. No questions arise.

The attendees are asked to approve the Treasurer's report. 72 votes have been received – 70 yes / 0 no / 2 abstention Action: The Treasurer's report is approved by the assembly.

Both Voting Auditors, Frédéric Vangroenweghe and Alfonso López confirm the results of the voting.

MB is leaving the Board and HN thanks her for all hard work done in the past years.





6. Amendments of the Constitution and Bylaws

H. Nathues

HN highlights the two main changes in the C&B

- "Internationally recognised specialists" (some criteria to be fulfilled, in the Bylaws a long list of what defines the Internationally recognised specialist is available)
 - Can submit the credentials
 - Once approved -> eligible to sit the exam
- Flexible Pathway
 - Can collect EC during 8 years (accredited/approved by ECPHM)
 - Once 180 EC have been collected ->can submit credentials
 - Once approved -> eligible to sit the exam

HN informs the attendees that once this has been approved the Board would start working on details and would be supported by the EBVS.

HN asks whether there are any comments or questions to address before voting.

Dominic Maes asks to explain better the EC. HN explains that one European credit stands for 24 to 30 hours of learning activities.

Voting is open - 77 votes have been received – 73 yes / 2 no / 2 abstention

Both auditors confirm the voting results.

Action: The amendments to the constitution and bylaws have been accepted.

7. Nominations & election

P. Martelli

PM explains to the audience that the open positions were announced approximately 3 months before the AGM, as the nominations should be received minimum two months before the AGM.

Paolo Martelli gives an overview of the Board members and reports on the open Board position.

PM points out that this year we have a very important election, the Vice-President needs to be elected. In addition Doris Höltig, elected last year will replace definitely Monica Balasch in a position of Treasurer.

PM informs the attendees that a new Vice-President will become ex officio member of the Credentials Committee, the Education Committee and the Examination Committee.

In addition two new members of the Examination Committee are needed.

Mari Heinonen will leave the position of the Chair of the Examination Committee and will be replaced by Marianne Oropeza Moe.





Two financial auditors need to be elected. Both Alfonso López and Frédéric Vangroenweghe can be renominated and re-elected.

Board Position - Approval by AGM for Vice-President

1 position -> 1 candidate **Carl Andreas Grøntvedt** nominated by Elisabeth grosse Beilage and Mari Heinonen

The nominee is asked to briefly introduce himself. **Voting results:** 79 votes – 72 yes / 0 no / 7 abstentions. PM welcomes the new Vice-President to the Board.

• Examination Committee Positions

Two open positions in the Examination Committee and two candidates: Alexander Grahofer nominated by Mari Heinonen Elisabeth grosse Beilage nominated by the ECPHM Board

Voting result:

Alexander Grahofer receives 77 votes - 73 yes / 1 no /3 abstentions. Alexander Grahofer is a new member of the Examination Committee. Elisabeth grosse Beilage receives 80 votes - 70 yes / 3 no /7 abstentions. Elisabeth grosse Beilage is a member of the Examination Committee

• Appointment of two Financial Auditors

Two financial auditors need to be elected from the floor for one-year position. The duty is to evaluate the financial issues of the College from the past year. The volunteers are needed from the floor.

PM has already asked Alfonso Lopez and Frédéric Vangroenweghe whether they are available for the next year and they both accepted.

Action:

Alfonso Lopez and Frédéric Vangroenweghe are appointed for one-year Financial Auditor position.

PM thanks two financial auditors for serving the college.
